

PLAYER POSITIONS AND THEIR DUTIES

LEADS

- 1. THE LEAD IS THE FIRST TO PLAY.
- 2. THE LEAD MAY, IN SOME MATCHES, BE RESPONSIBLE FOR CONDUCTING THE TOSS OR "CALLING" TO ESTABLISH POSSESSION OF THE JACK FOR THE FIRST END.
- 3. THE WINNING LEAD PLACES THE MAT, DELIVERS (CASTS) AND CENTRES THE JACK.
- 4. THE LOSING LEAD, AT THE COMLETION OF THE END, USES THE PUSHER TO COLLECT AND RETURN THE BOWLS TO A POSITION BEHIND AND TO THE SIDE OF THE MAT.
- 5. THE AIM FOR THE LEAD IS TO BOWL AS CLOSE AS POSSIBLE TO THE JACK.

DO'S

- 1. CAST A DIFFERENT JACK LENGTH TO YOUR OPPONENT'S IN THE TRIAL ENDS.
- 2. GET YOUR BOWLS AS CLOSE AS POSSIBLE TO THE JACK. THE IDEAL IS JUST BEHIND THE JACK SLIGHTLY TO EACH SIDE.
- 3. IF YOUR OPPONENT IS HOLDING SHOT ATTEMPT TO DRAW ALONGSIDE TO PROVIDE A WIDER TARGET FOR YOUR NUMBER 2 OR 3.
- 4. PRACTICE, PRACTICE, DELIVERING THE JACK TO DIFFERENT LENGTHS ACCURATELY AND TO LENGTHS WITH THE MAT MOVED UP THE GREEN.

DON'TS

- 1. DELIVER YOUR BOWLS SHORT.
- 2. TRY NOT TO PRESENT A TARGET FOR YOUR OPPOSITION BY DELIVERING YOUR BOWLS TO A JACK HIGH POSITION.
- 3. GUARD AGAINST TOO TIGHT A LINE WHICH WILL RESULT IN A BOWL THAT HOOKS PAST IN FRONT OF THE JACK.
- 4. NEVER BE TEMPTED TO TRY AND REMOVE AN OPPONENT'S BOWL AS THIS WILL INVARIABLY RESULT IN A WASTED BOWL THAT HAS LITTLE OR NO FURTHER VALUE IN THE OUTCOME OF THAT END. IN ADDITION, THIS IS A SHOT THAT SHOULD BE PLAYED BY A LATER PLAYER.

SCORING YOUR OWN GAME

- 1. HOW OFTEN WAS I SUCCESSFUL IN ACHIEVING THE REQUESTED JACK LENGTH.
- 2. WHEN ALLOWED TO CHOOSE THE JACK LENGTH WHAT DID I BASE MY DECISION ON
 - a) MY FAVOURED LENGTH
 - b) THE LENGTH, I BELIEVE, MY DIRECT OPPONENT DIDN'T FAVOUR
 - c) THE LENGTH, I BELIEVE, THE OTHERS IN MY TEAM FAVOURED
 - d) THE LENGTH, I BELIEVE, THE OTHERS IN THE OPPOSING TEAM DID NOT FAVOUR
- 3. HOW DID I REACT WHEN MY OPPONENT HAD SHOT, DID I ADD WEIGHT OR KEEP DRAWING.
- 4. HOW MANY OF MY BOWLS WERE ON TARGET, HOW MANY TOO HEAVY OR SHORT.
- 5. HOW MANY ENDS WERE WE AHEAD WHEN THE LEADS HAD FINISHED BOWLING I.E. DID I PERSONALLY BOWL BETTER THAN MY DIRECT OPPONENT.
